# ALCOHOLICS ANONYMOUS 30TH ANNIVERSARY

The Fourth International Convention being held this week in Toronto, Canada, marks the 30th year of growth for the fellowship of Alcoholics Anonymous.

Approximately 14,000 AA members are expected to attend. However, nearly a half million other AA's all over the world will be in Toronto this week, if only in spirit, to share their most humble and profound gratitude.

A significant honor has been accorded to Orange County AA and Al-Anon by the invitations extended to Chuck C., of

Laguna Beach, and Theresa G., Dana Point.

Chuck will be one of three speakers in the closing spiritual meeting of the Convention, sharing honors with a Catholic Priest and a Protestant Minister. The subject will be "God as we understand Him".

Theresa has been chosen to be a panelist in the Al-Anon Panel meeting.

It is both timely and appropriate that June 27th through July 4th has been chosen by the General Service Conference as "A.A. WEEK"!

## G.S.O.

A.A. TO VOTE ON A CHANGE IN ITS  
BOARD OF TRUSTEES

At the 1966 General Service Conference  
our Delegates will vote on a proposal to  
change the composition of the General  
Service Board. For some time there has  
been discussion of a suggestion to change  
the structure of the Board, which present-  
ly consists of 10 Class A ( Non-alcoholic )  
Trustees and 9 Class B ( AA ) Trustees. As  
reported in the Early Bird edition of the  
1965 Conference Digest, the Board has  
now presented a unanimous recommenda-  
tion to change its structure. When the de-  
tails of the plan have been made public,  
it can be studied and discussed in AA  
Groups throughout the world. The General  
Service Representatives will bring the  
thinking of their Group to their Delegate  
to help him when the plan comes up for a  
vote at next year's Conference.

This news was part of the report presented  
by Tom A., our Delegate, at the last Gen-  
eral Assembly of G.R.'s at the Alana Club  
in Anaheim. Before Tom left for the 1965  
Conference he had given us a list of items

which would be discussed there. This pro-  
vided an opportunity for each G.S.R. to  
get the ideas of his Group. In our New-  
port Harbor District #6, these ideas were  
then pooled at the workshop Potluck held  
jointly each month with Laguna's District  
#12, so that they could be passed on to  
Tom A. The conference agreed with many,  
but not all of the ideas.

Some of the highlights of Tom's report:

In connection with the 30th Anniversary  
Convention, 3500 letters were sent out to  
the press earlier this year. The advertising  
Council will announce AA Week- June  
27th to July 4th. There are eight times as  
many groups as in 1954. While services  
have been greatly expanded, the cost per  
group has been considerably reduced.

Where the Monthly Sharing Plan was intro-  
duced the number of groups contributing  
increased 20%. It was decided to adopt  
the plan throughout the United States and  
Canada. Our Area had already voted to  
use the plan for our contributions.

There was almost unanimous agreement to  
reject the suggestion that the term of del-

egate be extended to 3 years. There was more discussion that ex-delegates be permitted to attend the Conference, but this too was voted down.

The item concerning AA Family Groups drew the greatest amount of discussion. It was emphasized that the General Service Office had great difficulty determining whether contributions should go to AA or Al-Anon. The consensus ultimately reached was that Non-AA's should not hold office in regular AA Groups, and conversely, that groups which included non AA's as regular members (eligible for office) should not carry AA in their name. In the discussion on the progress of cooperation between AA and Al-Anon, representatives of G.S.O. requested that a clear distinction be drawn between matters concerning AA and those concerning Al-Anon in any correspondence with the office.

It was brought out that Young People's Conferences had been wonderfully successful in one area and had had financial problems in another. Tom presented a favorable report in our area, where an International Conference will be held in August. The subject of special Beginner's meetings unfortunately received little discussion. The usual format of these was found to be discussions of the 12 Steps and 12 Traditions.

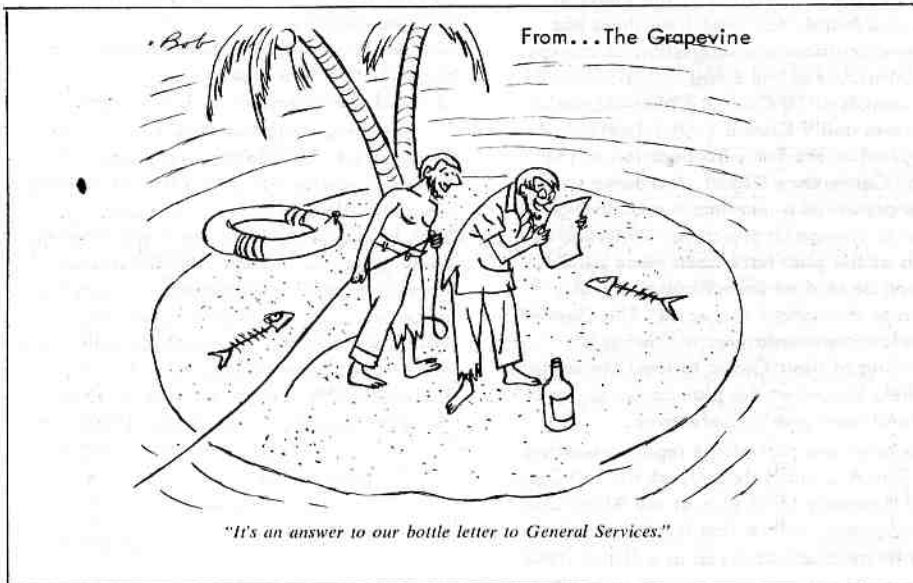
Concerning the value of the Grapevine in carrying the message, AA's were urged to take a copy along on 12 Step calls, particularly where there might be difficulty in having the prospect identify with the caller. It was recommended that more emphasis on General Service in the Grapevine would be good. The idea of presenting Grapevine subscriptions for AA Birthdays was mentioned.

It was agreed that Anonymity and the 11th Tradition were as important now as they were in the early days. Concerning the role of the General Service Conference in A.A., it was brought out that the Conference had helped to integrate the groups in different areas. The fact that more older members are coming out of "retirement" and becoming active again can be partly attributed to the influence of the Conference.

A new film on General Service and AA World-wide will soon be available, but each Area will have it for only a few days. Our districts will be alerted when the film is due to arrive, so that it will be available as widely as possible.

Concerning registration for the Convention. The number had reached 6000 at the time of the conference, and they expect an attendance of 15,000.

# Cunning, Baffling, Powerful"

SPLINTERS FROM THE BOARD

Again writing in mid-air, returning from Portland, full of many memories. Having participated in Oregon's first State Al-Anon Meeting, attended Saturday night by over 450, and subsequently being put "On the Spot" at a breakfast the next morning via a question and answer format, we feel even more optimistic about the future of A.A. Why do we say AA's future? Because of the personal recognition, shared by many others, of the impact and importance of Al-Anon growth directly on our AA Fellowship, whether the individual might accept that effect or not.

Seeing the competence, enthusiasm, and dedication which was so evident in the handling of this State Meeting, may we again suggest that we of AA open our eyes and see Al-Anon for what it has really become. To do otherwise would be foolhardy.

Al-Anon is no longer a fledgling group of non-alcoholic mates. Its rate of growth, numerically, far surpasses that of A.A. It is no secret that they closely parallel AA in Services provided, objectives, and accomplishments. Their World Service Conference is now in its 5th year. All indications point to our recognizing Al-Anon as a "force", so to speak, to be reckoned with.

Certainly, the counterpart of the current non-alcoholic mate has been with us from the very inception of AA, as an influential and active entity long before the formal fellowship of Al-Anon was instituted. Al-Anon today is as "organized and stable" as AA considers itself to be. To fail to recognize its effect on our members, old, current, and newcomer would seem to invite imminent disaster.

Let us consider only 3 very obvious facts. First, we in AA have contact with the alcoholic from an average of possibly one and one half hours a day assuming that he or she attends a meeting every single night. This, obviously is not prevalent, so it

even increases the odds. However they are subjected to the overall relationships with their mate, on Al-Anon or not, for about twenty-two and one half hours.

( We know all alcoholics know this to be true). Some of us may be egotistical enough to profess that our small portion of activity with the alcoholic can, and does, offset or counteract the tremendous influence of the mate. This is not basically very realistic, it would seem.

Rather, should we not be concerned over what type of relationship is dealt to the newcomer, particularly by the Al-Anon member? We have no desire to make any change in Al-Anon, whatsoever, but would it not behoove us to know what they really stand for, really try to do, and really convey to their alcoholic mates? It appears that far too many of our membership do not understand Al-Anon as it is functioning, with only a surface knowledge of what it is, and what it is not, what it can and cannot do. AA's responsibility lies in making a conscious effort to understand Al-Anon in all phases. Probably the best reason advanced is in the interest of those newcomers of the future who have non-alcoholic mates to be included in the overall picture, one way or the other.

Lastly, we propose that the Al-Anons are, to borrow a phrase from our Big Book, very much the "cunning, baffling, powerful" part of our "Family Disease". This has no taint of the negative, but rather can be a very positive observation. AA might consider that, in our own interests, we could well benefit by having that "cunning, baffling, and powerful" segment on our side. Only by full understanding of each other's programs, efforts, and problems, can both Fellowships be an aid to both the AA member and the new member of Al-Anon.

We in the Sacramento Valley might be a

leader in showing this type of cooperative action, keeping in mind that absolute necessity of complete autonomy, and with no thought of amalgamation or consolidation. (I am sure the AI-Anons would not let us in, anyway.)

This subject is of sufficient importance to be on the presentation agenda in N.Y. at the World Conference this month, and hope that all AA's and AI-Anons will be

interested in the outcome of that discussion, and suggested approaches.

One final question. "Stop and ask yourself if your mate had anything important to do with your present sobriety."

# Honor Farm

FOR MEN ONLY!!!!!!!!!!!!!!!!!!!!!!

If you are willing to share your experience strength and hope with men who want your help to become acquainted in A.A. there is a very rewarding opportunity for you to become a volunteer sponsor for men coming out of the Orange County Industrial Honor Farm.

Many of these men are self committed for alcoholism. About half of them have never attended meetings or known anything about the nature of their illness, the other half have had varying lengths of A.A. contact. All of them are members of the Honor Farm A.A. Fellowship which has two speaker and one participation meeting each week.

The seed has been planted, the problem recognized and admitted, and a sincere desire aroused to do something about it; hope has been instilled that A.A. will provide the directions; they are open minded and willing.

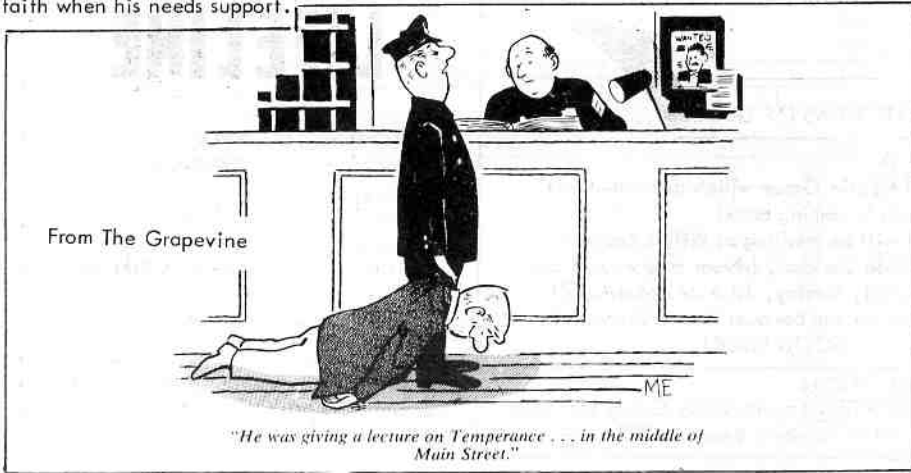
Sponsorship consists of visiting the specific member assigned to you, at any reasonable hour, at the Honor Farm and becoming acquainted. Four visits are available to the sponsor during the last thirty days before the inside member's release. On release the sponsor is expected to help the new member find groups where he feels he gets the help he needs; to be someone he can turn to for suggestions; to share your faith when his needs support.

We do not promise jobs or material assistance of any kind. As a sponsor, your writer has found every case individual; his only solution has been to try and place himself in the other fellow's shoes and ask what he would hope would be done for him. How this is handled is sponsorship.

If you desire to share in this most rewarding of All A.A. activity, turn in your name, address and telephone number to your Orange County Central Office as an Honor Farm Sponsor. Volunteers are requested from every group in Orange County as the men are from all parts of the county and sponsors are desired in their home areas. Group secretaries are asked to cooperate in announcing this need to their members and assisting in forwarding names to the central office.

Each sponsor will be phoned personally before a new member is assigned to him; he will be furnished with the name of the man and his release date; any questions he may have will be fully answered; on his acceptance, his name will be forwarded to the Honor Farm and visiting privileges requested for him to sponsor the specific member assigned to him- from there on our Higher Power must guide us- may He continue to bless us all.
