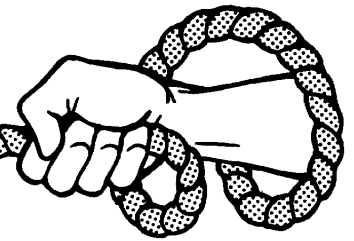

"The Last Talks of A.A.'s Co-Founders"

When I was asked to join the Board of Directors of the National Council on

Alcoholism-Orange County (N.C.A.-O.C.) I read our A.A. literature pertaining to A.A.'s official position on relationships with outside groups in the field of alcoholism. It was an excellent exercise in discovering the meaning and intent of our Traditions, the 6th in particular. At the outset it was clear that there are no written or implied restrictions on individual A.A.'s actions or affiliations outside of the Fellowship, except those relating to anonymity in the media, and the understanding that none of us "represent" A.A. as a group - especially in terms of endorsement or affiliation. It is also clear to

me that "cooperation" on the part of A.A. is encouraged.

However, in discussion with some members of the Fellowship, I also became aware that too often some of us interpret only the negative, proscriptive aspects of the Traditions, as if this were their sole function.

Imagine how A.A. would grow if everyone in A.A. became a "sponsor/friend" of just ONE PERSON EACH this year.

Try to imagine how our faithful Volundears feel when they make call after call to get a 12th Step worker and can get no one because they are too busy or there is no answer and we have run out of names on our much too small list of 12th Step workers.

The responsibility of being a sober member of Alcoholics Anonymous is to "CARRY THE MESSAGE".

## THE BEST OFFENSE IS A GOOD DEFENSE

It is a historical fact that any great leader of any army, in order to obtain victory, must have a plan. This plan must constitute the pro's and the con's - the good ideas and the alternates - the immovable defense and the resistible offense. When his offensive team takes an objective, he must set up a defense to hold whatever they have taken or all has been in vain. We, alcoholics, should take offensive action against our enemy, Alcohol.

During all my years of drinking, I thought alcohol was my problem. Alcohol was my release. I was mostly my own problem. Knowing this, I now have to work on a solution, turn myself around and go the other way. I used to measure everything I did by alcohol. Do I have enough to last the day? Cut the lawn? Wash the car? Will the people where I am going serve enough cocktails? If not, I would fortify myself before I left the

## UNITY IN A.A. -- LOFTY IDEAL OR PRACTICAL NECESSITY?

Many of us come into the Fellowship of Alcoholics Anonymous burdened with a hundred pressing problems, not the least of which is a taut preoccupation with self – MY feelings, MY attitudes, MY needs and desires.

When we realize, early on, that this self-centeredness is a common denominator with other alcoholics and that many who have preceded us in the Program found the means to love and serve (forgetting self) we are usually encouraged to practice the teachings of the Program designed to relieve the restrictions of self-involvement. The importance of the groups is recognized; the preservation of the Fellowship itself becomes paramount.

In *A.A. Comes of Age* we read "...the temporary or seeming good can often be the deadly enemy of the permanent best. When it comes to survival for A.A. nothing short of our very best will be good enough."

And in a letter from Bill W. he writes "As sobriety means long life and happiness for the individual, so does unity mean exactly the same thing to our Society as a whole. Unified we live; disunited we shall perish".

We read and study these statements and see the logic behind them, but then face the question "What has the idea of unity in the groups or the Fellowship as a whole have to do with MY sobriety? A great deal, it seems. Since my own entrance into A.A. in 1954 I have watched with dismay the effects of dissension, power struggles and self-seeking in various areas of A.A. service. Fortunately, the effects were mostly short-lived and the members affected were able to recover

balance and get on with the business of sobriety. But in every episode a lesson was provided.

Our co-founder Bill stated, "If trouble ever comes to A.A. it will be from within, not from outside forces."

I owe my life to the A.A. program and the people in it. I pray that our Fellowship will always be united and that we can stand together for the common good, remembering "Love and Tolerance is our code".

house. I was always taking inventory of how much alcohol I would need to get the job done.

Being aware of my problem is the first step, along with the admission that I am powerless over alcohol. If I have fully surrendered my life to this factor, I am now ready for the acceptance of my problem. Without this I can not go forward. A total surrender is the keyword here. Having acknowledged the awareness of my problem and having accepted that I am alcoholic, I am now ready for the action. What to do about the problem.

There is NO set way to getting sober or staying sober. Each of us is different and must plan our own strategy accordingly. Don't drink – meetings – association with other alcoholics – phone calls – getting involved in all phases of alcohol designed get-to-gathers.

From the very beginning, the 12 steps of A.A. must be worked on a daily basis. These steps become the very defense of our Sobriety. Working with other alcoholics is a strong defense to MY Sobriety. All in all, the very offensive action I take against the disease becomes the defensive as well.

Without the drug, alcohol, my Belief and Value System is now more in balance. My intellect has now returned to me without the drug and I no longer operate on drunken emotions.

Being sober, I now have a choice and am learning that my choice, either right or wrong, is O.K. If I choose the wrong way of action, this is all right, too. Because I can go back and try and try again until I am right – this is my reward.

It has become a marvelous feeling to have someone talk to me and for me to be there! I am very much involved in A.A. and Hospital and Institution work. My offensive action I take in doing this work has strongly become my natural defense. My time at the Rehabilitation Hospital, where I was approximately four years ago, gives me some of my most cherished moments. I am able to talk with the NEW newcomers in their rooms on a one-to-one basis about their problems. They seem willing to open up and talk of some of their most secretive happenings in life. To me, this is priceless.

I am writing this in an endeavor to tell the still suffering alcoholic how to find the solution. Remember, we must stop drinking alcohol, straighten out our thinking and learn to either control or discipline our emotions. If not, we will fail. Remember, the alcoholic has the unique ability to have a stronger fear of staying sober than he does of the consequences of drinking even though he knows and admits he's an alcoholic. My offensive is the things I work at to stay sober. My defense is remembering *who* and *what* I am – that is – I am alcoholic.

## TO ALL GROUPS IN ORANGE COUNTY

As you may know, the Orange County Intergroup Association of Alcoholics Anonymous and Central Office was established and incorporated twenty-one years ago by the groups within the County in the spirit of unity with the express purpose of establishing a Central Office through which the group members and the community could be served effectively. (See Statement of Purpose attached.) This Association and the Board are your trusted servants. Now that we have nearly 500 groups in Orange County, we must always be objective on what is best for the membership as a whole.

We have recently been advised that an effort is being made to start another Orange County Central Office. This letter is to indicate that at present there is no connection between Orange County Intergroup Association of A.A. and any other Orange County Central Office. No so-called "satellite" central office is being considered at this time.

- No requests have been received from any Orange County groups presently being served by the existing Orange County Central Office, 2712 So. Grand Ave., Santa Ana, to initiate such an office in Orange County.
- We have not been informed of a valid need for such an office.
- Representatives of the proposed North Orange County Central Office did not present a statement outlining proposed services and operating procedures (see Tradition Four, long form) at the March 9, 1982 Intergroup meeting, although invited to do so.

Therefore, the position taken by members of Orange County Intergroup Association in regular session March 9, 1982 is that until such time as a sufficient number of groups served by the existing Central Office, 2712 So. Grand Ave., Santa Ana, indicate their need for a North Orange County Central Office, we cannot endorse or support such a project.

This message is brought to the membership of all groups in Orange County to encourage and seek your consideration for the welfare of Orange County A.A. in the true spirit of unity.

Well - ??? Had my sponsor done such a thing with me, I expect I would have turned, hit him in the nose and walked out. The myth that a sponsor is an arrogant, hard boiled old goat that gives such orders right and left while he struts around in pride, bragging about how he humiliated that punk is pure and unadulterated poppy-cock.

The sponsors of olden times were just what they should be; humble, interested men and women who had a message of hope and love for their new found baby and were first and last, **teachers**, givers of themselves, and diligent workers at **just that**.

The modern day old-timer of 20 years is one who found A.A. in 1962 and alcoholism was by then an "illness," and was treated as such. But the old timer who came into the program in 1950 faced the same ostracism as did those who came before that time and were so grateful they could give it away daily.

A good sponsor is someone who has made of themselves a person they approve of, capable of, and always aware of, having been recalled from disaster, loved and taught to take up a new life and clear away the mistakes of the past, **then** as it was given to them, always to be available to give that hope, that inner peace, the return of self-worth to every single one they were sent, if possible.

Let's begone with the "sit down, shut up and listen" poppy-cock and get back to loving the unlovable, back into a useful, magnificent life.

Remembering that the Traditions apply to A.A. groups and the Fellowship as a whole does not suggest that, as individuals, we are not free to (indeed, we are encouraged to) develop a sense of social responsibility which is not confined to Alcoholics Anonymous.

As early as 1947, Bill W. wrote on the difference of opinion, between the "do-nothings" who would have us stay away from all alcoholism-related programs outside of A.A., and the "do-everythings" --enthusiasts who would have A.A.'s proclaiming "the message" in every outside forum available! He concluded: "to my mind, the "do-nothing" policy has become thinkable, partly because I'm sure that our members can work in other non-controversial alcohol activities without jeopardizing A.A., if they observe a few simple precautions; and partly because I

have developed a deep conviction that to do less would be to deprive the whole of society of the immensely valuable contributions we could almost certainly make."

With these understandings in mind, I began what has now been over a year of involvement with the National Council on Alcoholism-Orange County. And, outside of my primary affiliation with A.A., it has been one of the most rewarding experiences in my sobriety. Most importantly, it has taught me that many non-alcoholics do share with alcoholics a deep commitment to education about and treatment of alcoholism -- that, as is the case with other national volunteer organizations which devote their attention to diseases such as cancer or lung disease or diabetes, people don't have to have the disease in order to be concerned about it!

It is my personal belief that members of



## To Be Fair-Minded

Too often, I think, we have depreciated and even derided projects of our friends in the field of alcoholism just because we do not always see eye to eye with them.

We should very seriously ask ourselves how many alcoholics have gone on drinking simply because we have failed to cooperate in good spirit with these many agencies - whether they be good, bad, or indifferent. No alcoholic should go mad or die merely because he did not come straight to A.A. at the beginning.

Our first objective will be the development of self-restraint. This carries a top-priority rating. When we speak or act hastily or rashly, the ability to be fair-minded and tolerant evaporates on the spot.

## TODAY IS THE DAY

A very demoralizing event took place in February of 1947. I was declared an alcoholic by my peers, by my family, and by my church. I was not happy by this declaration of weakness in me by them! I had listened to their advice over the years: Drink like a man – don't drink so much – control your drinking, etc., etc., etc. Sadly enough, I thought I was handling it OK. Because of the cunning nature of the disease, I did not notice the progression.

Now, I had to take an inventory. What happened? When did it all start? Was I born an alchy? Was I a weakling with no principles? I knew I did not want to react to alcohol the way I had been reacting. I did not want to embarrass my family, friends, or myself. Yet it was happening. Where do I go? What do I do? A narrow-minded wife suggested I do something, or SHE would do something.

A program call A.A. was mentioned, and it sounded like the most degrading program I had ever heard of! They were a bunch of drunks out to save the world. Sort of like a group of Skid Row religious freaks. These were the thoughts that went through my

mind. Of course, I was not in a position to argue. The deck had been stacked, and they were dealing me a losing hand.

I played the silly game and joined A.A. I did not openly admit to being an alcoholic until six months after joining. It scared the daylights out of me, yet I feel this is when my involvement in the program reached its peak. Now it was 100 percent – everybody knew I was an alchy, and a feeling of relief seemed to set in. Things began to happen. The Steps, traditions, and legacies became challenges. I wrote and rewrote them several times. I picked up a sponsor, perhaps the rottenest man God created. He laughed at me, ridiculed me, loved me, and saved my life! He was without a doubt the best thing that happened to me. I became active and overactive. I would, on occasion, tell them how to run the Central Office, the group and their lives. I was a bleeding deacon at times, giving advice whether they wanted it or not.

Instead of sharing my experience, strength and hope with people, I was imposing it upon them. Some rebeled, and some objected, but most allowed it to happen, and loved me back to reality. That's a little of what it used

to be like. And what is it like today? I'm a bit older and wiser, I hope! I see members doing some of the same goofy things I used to do, and I think for the most part, that's healthy. Wouldn't it be awful if we all reached that stage of perfection referred to in our Book. Can you imagine what it would be like to have no character defects? I still enjoy some of mine. I have a little plaque which reads:

I do my thing, and you do your thing  
I am not in this world to live up to your expectations

And you are not in this world to live up to mine

You are you and I am I  
And if by chance we find each other  
It's beautiful
